Dear Friends,

We are fortunate to live in an area that is vibrant, thriving and has a culture of partnerships. Without partnerships, we would not be able to do the work we do and make an impact in the community. With home values rising faster than incomes, Habitat and the City of Alexandria were looking for solutions to address the affordability gap.

This summer, we broke ground on Summer Meadows, an affordable housing development made possible with a partnership between the city and Habitat for Humanity of Douglas County. The City of Alexandria, Douglas County, and the school district all participated in Tax Increment Financing, which helps to fund the public infrastructure of this project, making all the homes affordable and making this project possible.

This fall, two community partnerships will help build two new homes adjacent to the Summer Meadows development. Carpentry students from the Alexandria Technical and Community College will build the Legends home and the CAPS students from Alexandria Area High School will participate in the Cardinal Build alongside volunteer groups. Partnerships like this benefit everyone involved by offering more affordable housing to the community, while students learn lifelong skills and gain exposure to a future career.

Another great partnership to highlight is the new State Housing Tax Credit Program and Contribution Fund. We have already received contributions for homes that will be adjacent to Summer Meadows. To those who have made contributions, thank you! I invite others to consider participating in this program.

For example, if you owe \$1,700 on your Minnesota state income taxes as a business or an individual, you can contribute \$2,000 to one of our current projects. You will receive a certificate for a \$1,700 tax credit. This is a win-win situation, and we encourage you to take advantage of it. The tax credits are available on a first-come, first-served basis.

When you contribute, you support affordable housing and can qualify for a state tax credit of 85% of your contribution!

- Who can contribute? Any person or business that pays Minnesota taxes and meets eligibility requirements can contribute.
- **How much can I contribute?** To qualify for the tax credit, contributions must be at least \$1,000 and cannot exceed \$2 million each tax year.
- How do I contribute and claim the credit? To contribute to the State Housing Tax Credit Program and Contribution Fund, you will need to fill out an application. It takes about 10 minutes to complete the application. You will get an e-mail within one week, asking you to DocuSign and send your funds via check or bank wire.
- What happens to my contribution? Contributions will be used to develop and fund affordable housing right here at home by selecting a Habitat for Humanity of Douglas County qualified project.

Earthwork progress in August

Habitat for Humanity of Douglas County broke ground on Summer Meadows, the first affordable housing development in Alexandria since 2002 and the largest project in the 27-year history of the organization.

The community gathered at the Ground Blessing ceremony held July 9 to celebrate the momentous occasion. Lori Anderson, Habitat Executive Director shared, "Through building 42 affordable homes, we're not just building houses, we're helping families stay afloat and build a brighter future." Among those present included Alexandria City Mayor, Bobbie Osterberg, who commented on how Summer Meadows is an example of the "coming together of so many people and resources to create something greater than the individual parts."

Through the partnership of the City of Alexandria with approval of the Planned Unit Development, the guidance and insight from the Alexandria Area Economic Development Commission to achieve TIF financing, and the USDA Rural Development site loan, the Summer Meadows development is a testament to the unwavering support of the Habitat founders, volunteers, donors, supporters, and everyone who believes in the mission.

Tony Loosbrock, Habitat Board Past Chair, commented, "I am so excited for the 42 future Habitat homeowners, who are such strong and determined people, striving to better their lives and keep growing. We are blessed to serve them." Habitat homeowner and Board Director, Jenna Hill, explained, "My family has been in our home for two years and we are still in awe. Habitat has impacted our lives now and forever. I used to feel ashamed that I could not provide my children with a home they were proud of and have friends come over," adding, "Life hasn't always been easy for me, but one obstacle I no longer have to worry about is affordable housing and a place for my kids to feel safe and loved because we have that! We can now create memories and build a future – this is the feeling for 42 more families here. Without hope and this community believing in Habitat's mission, I wouldn't be standing here today to tell you all thank you. Because of this community, not only does my family have a home, but we will continue to bless many other families. Thank you."

Earthwork began in July and will continue into this fall. Upon completion, water, sewer, and the new road — Seasons Drive — will be completed. Next spring, construction on the first homes of Summer Meadows will begin. Habitat's strategic plan is to build five homes this year and next. In addition to building within the Summer Meadows development, Habitat will continue to build homes throughout Douglas County as opportunities arise.

Donor Spotlight


The housing crisis has made homeownership a distant dream for many families in our own community. Chad Swanson, a dedicated Habitat for Humanity volunteer, understands this struggle firsthand. As a parent, Chad empathizes with the challenges of homeownership and the aspiration for a stable home.

Several years ago, Chad was invited to the Hard Hat Events. While he did not immediately get involved with Habitat, the tide turned when he noticed Habitat homes popping up in familiar neighborhoods. "These were families enjoying maybe their first home and getting out of an apartment. I have always had an interest in construction since it was my father's hobby and thought I may have something to offer," shares Chad. "Obviously, on my first day as a crew lead volunteer, I was apprehensive about how I would fit in. I was so impressed with the crew members' dedication and knowledge at each site. I felt very welcomed by the Habitat construction staff and crew members," he adds.

"It's been many years ago when we rented an upstairs house furnished apartment for \$80 per month. We are now seeing \$350,000 starting homes, a staggering figure for young families," Chad explains. The stark reality is that many families in Douglas County spend more than the recommended 30% of their monthly income on housing. As seen in the graph to the left, the top five in-demand jobs are not able to afford a median-priced home in Douglas County.

Build Updates



Team Build Home

Cabinets, flooring, landscaping, and interior trim have been completed in Homebuyer Angel's home. All these details make "everything feel so real!" Finishing details will round out work this fall as we near completion of the home. One of the hardest times for homebuyers is when construction is complete and finalization of the loan process begins. During this time, the home waits, along with the homebuyer, in anticipation of closing and move-in day. A home dedication will be scheduled this fall.

Construction on our Women Build home began in June. All exterior work has been completed, except for landscaping. Interior work is in progress with insulation, sheetrock, and painting done. Cardinal Build Home

Homebuyer Jayde is also eager to provide a stable environment for her three children. "When I received the call that I was approved, I reacted with pure

excitement. I felt a sense of relief." Construction on Jayde's home will begin this fall. Students from the Alexandria Area High School EMTNR CAPS class will help build the home during their class time alongside volunteer groups. Both the Cardinal and Legends Build homes will be built adjacent to Summer Meadows.



Legends Build Home

This fall will be the third Legends Build built through a partnership with carpentry program students from Alexandria Technical & Community College.

Having moved 12 times, Homebuyer Codie shared, "My kids need stability...I am looking forward to a safe place for our family."

ReStore Corner

Habitat for Humanity ReStores are independently owned stores operated by local Habitat for Humanity affiliates that accept donations and sell home improvement items to the public at a discounted price.

Habitat for Humanity ReStores play an integral part in Habitat's mission as proceeds help provide financial support and sustainability to the affiliate.

Additionally, the ReStores contribute to keeping materials out of our landfills. Since our ReStore opened in 2014, we have kept **1,706 tons** out of the landfill!

Our ReStore participates in multiple programs and partnerships:

- Cardboard Cares (pictured top right): This summer, our ReStore began a partnership with Cardboard Cares, a local nonprofit helping local area businesses with cardboard recycling. Proceeds from recycled cardboard donations are returned to the community via visual art instruction at little or no cost. To learn more about the organization, visit <u>cardboardcares.org</u>. The red bin is located in the parking lot, next to the organics recycling area.
- Soles 4 Souls (pictured middle right): Located near the ReStore entrance, the ReStore is now a drop-off spot for the Alexandria Lions Club initiative. The Lions Club has been collecting pairs of shoes which they bring to Soles 4 Souls, a nonprofit that turns shoes and clothing into opportunity. Shoes are then distributed throughout the US and worldwide. To learn more about the organization, visit soles4souls.org.
- Porganics recycling (pictured bottom right): Since 2019, the ReStore parking lot has been a drop off site for organics recycling through Pope/Douglas Solid Waste Management.

 Organics recycling is an important part of effective waste management programs. Items are returned back to nature, reducing resource use and greenhouse gas emissions. Visit popedouglasrecycle.com to learn more about what items are accepted.
- Metal recycling: Did you know that any unsold lights and other items containing
 metal are deconstructed and the metals separated out for recycling? After
 separation, the metals are collected for a special metal recycling site.

When you donate to and shop at the ReStore, you help the environment by

- reducing the amount of waste and need for new items,
- reusing things that still have value, and
- · recycling items rather than sending them to the landfills.



Help support Habitat for Humanity of Douglas County to build more homes in our county. The Minnesota State Housing Tax Credit Contribution Program (SHTC) is a new way to help finance affordable housing.

Eligible Minnesota corporate and individual taxpayers can contribute between \$1,000 and \$2 million to the SHTC Program fund, and, in return, receive a state tax credit certificate (TCC) that equals 85% of their total contributions. We encourage you to contribute to this program towards our current qualified projects.

Act now if you would like to take advantage of this opportunity. The program is limited to granting \$9.9 million in 2024. Once the credits are claimed, it will be closed for the remainder of the year.
