

THROUGH SUCH PROCESS, THE EXECUTIVE COMMITTEE WILL SOLICIT INPUT FROM THE EXECUTIVE COMMITTEE AND PRESENT PERFORMANCE EVALUATION FINDINGS TO THE BOARD OF DIRECTORS

SECTION 6.3 ADDITIONAL BOARD OF DIRECTORS COMMITTEES

EACH ADDITIONAL BOARD OF DIRECTORS COMMITTEE HEREIN LISTED SHALL CONSIST OF FOUR (4) MEMBERS TO SERVE IN SUCH CAPACITY UNTIL THE NEXT ANNUAL MEETING OF THE BOARD OF DIRECTORS. A VACANCY ON ANY OF THESE COMMITTEES MAY BE FILLED AT ANY TIME. MEMBERS OF ADDITIONAL BOARD OF DIRECTORS COMMITTEES MAY BE APPOINTED TO SUCCESSIVE TERMS. BOARD OF DIRECTORS COMMITTEES SHALL HAVE A COMMITTEE MANDATE. BOARD OF DIRECTORS COMMITTEES MAY INCLUDE, BUT ARE NOT LIMITED TO THE FOLLOWING:

FINANCE COMMITTEE

THE FINANCE COMMITTEE SHALL: (I) OVERSEE THE IMPLEMENTATION AND ADMINISTRATION OF POLICIES AND PROCEDURES FOR HANDLING AND ACCOUNTING FOR THE FINANCES OF THE CORPORATION; (II) PREPARE AN ANNUAL REVENUE AND EXPENSE BUDGET FOR SUBMISSION TO THE FULL BOARD OF DIRECTORS; (III) MONITOR THE IMPLEMENTATION OF THE BUDGET, AND (IV) WHEN NECESSARY, MAKE RECOMMENDATIONS TO THE BOARD OF DIRECTORS REGARDING ADJUSTMENTS TO THE BUDGET.

PEOPLE COMMITTEE

THE PEOPLE COMMITTEE SHALL OVERSEE THE IMPLEMENTATION AND ADMINISTRATION OF POLICIES AND PROCEDURES RELATING TO VOLUNTEERS AND EMPLOYEES, IF ANY, OF THE CORPORATION.

GOVERNANCE COMMITTEE

THE GOVERNANCE COMMITTEE SHALL BE RESPONSIBLE FOR IDENTIFYING AND RECRUITING PROSPECTIVE DIRECTORS OF THE CORPORATION AND SHALL PRESENT A SLATE OF NOMINEES FOR ELECTION AS DIRECTORS AT THE ANNUAL MEETING. THE COMMITTEE SHALL ALSO PRESENT A SLATE OF NOMINEES FOR ELECTION AS PRINCIPAL OFFICERS OF THE CORPORATION AND MAY MAKE RECOMMENDATIONS FOR CHAIRS OF THE OPERATING COMMITTEES. THIS COMMITTEE OVERSEES THE ANNUAL EVALUATION OF BOARD OF DIRECTORS MEMBERS.
