Qualifications

NEED

- Currently reside in inadequate housing (overcrowded, substandard, cost-burdened, or temporary)
- Living or working in Douglas County for at least the previous 12 months.



- Meet the income guidelines (see table)
- Demonstrate two years of consistent and verifiable income
- Current debt-to-income ratio does not exceed 43%
- Have no outstanding liens, collections, or judgments
- Be able to contribute \$2,200 towards closing costs
- Are three or more years from bankruptcy discharge (if applicable)
- Be a legal permanent resident or U.S. citizen

WILLINGNESS TO PARTNER

- Be prepared for each adult to contribute 200 hours of sweat equity (volunteer hours)
- Commit to completing the following requirements:
 - HomeStretch course
 - Budget counseling
 - Education courses
- Participate in home interview
- Able to maintain eligibility throughout the application process until closing

About our homes

A typical new house has 1,200 square feet of finished living space. Most homes have three bedrooms and one bathroom. Habitat uses green building practices to make the homes and their utilities affordable.




